## RECYCLABLE WASTE MANAGEMENT AGREEMENT

This Pangasinan State University's Ecological Solid Waste Management Project Agreement is made this December 01, 2020, at the Pangasinan State University Maln, Lingayen, Pangasinan, Philippines, by and between:

The Pangasinan Environmental Sustainability Advocacy Cooperative, Pangasinan, an organized cooperative with office at the 160 Barangay San Isidro Sur, Binmaley, Pangasinan, Philippines, represented herein by its General Manager, MR. REYNALDO B. ESGUERRA, hereinafter referred to as the "PESAC", 1st party;

and

Pangasinan State University, a government institution duly organized and existing under the PD 1497, with its main office at Alvear Street, Lingayen, Pangasinan, represented herein by its University President, DR. DEXTER R. BUTED, hereinafter referred to as the "Pangasinan State University", 2<sup>nd</sup> party.

The foregoing entities are hereinafter collectively referred to as the "Parties".

## RECITALS:

WHEREAS, the Pangasinan Environmental Sustainability Advocacy Cooperative (PESAC) whose vision is to become the center of sustainability in the field of environmental technology enterprises and other development in Pangasinan in 2030;

WHEREAS, under such vision, the PESAC seeks to involve its coop members in environmental activities and advocacies while earning; collaborate with academe and other research institutions in knowledge and technology transfer programs and to serve the Pangasinan people while protecting and conserving environment, culture and biodiversity;

WHEREAS, to partly implement that vision, the PESAC shall dutifully carry out its mission by serving the Pangasinan State University by collecting the recyclables of all PSU Campuses including the two graduate schools;

NOW THEREFORE, for and in consideration of these premises and the mutual commitments. obligations and undertakings assumed and accepted hereunder, the Parties have agreed as follows:

## TERM OF THE AGREEMENT

The 1st party, PESAC shall:

Binmaley

1. Collect only the recyclable wastes of every PSU campus including the graduate schools; yclables every last week of the month with the following schedule to observe:

Recyclable buying prices depends on the item/s, notification of the prices shall be provided by the PESAC through the in-charge of the recyclables of PSU and its campuses;

4. Buying payment of the collection of recyclables shall be on the scheduled buying and collection day;

The 2<sup>nd</sup> party, PSU shall:

1. Every campus/unit of the PSU shall be responsible with its recyclables and be collected by the assigned Administrative Aide prior to the buying/collection by the PESAC;

2. Face masks and face shields are not regarded as recyclables nor residuals and therefore not included in the collection. The recyclables are placed in a sack or any container by the assigned Administrative Aide prior to the collection by PESAC; and

3. Receive the buying payment from the PESAC and such shall be officially recorded and turned

over to IGP in-charge of the PSU campus/graduate school .

## TERMINATION OF THE AGREEMENT

The PESAC may terminate this Agreement if a Force Majeure Event prevents either Party from performing any of its material obligations under this Agreement. The PSU may require the Agreement to continue if the PESAC observes the recyclable buying/collection schedule and complies with the above agreement.
