The Pangasinan State University, intends to apply the sum of Six Hundred Forty Nine Thousand Nine Hundred Twenty Nine Pesos and One Centavos (P 649,929.01), being the Approved Budget for the Contract (ABC) to payments under the contract for the "Repair of the Pump Station, Aerator, Irrigation System, Control System Housing (Development of Smart Aquaculture Farm Management System (PSU-SAFMS) for Sustainable Fish Farming) at PSU Binmaley Campus"

Bids received in excess of the ABC shall be automatically rejected at the opening of the quotation.

The opening of quotation will be conducted as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Interested service providers may submit their sealed quotation at the Pangasinan State University, Lingayen, Pangasinan at the address given below during office hours at 8:00A.M.-5:00 P.M.

The deadline for the submission of quotation shall be on or before 10:00 AM of January 15, 2024, at the BAC Secretariat - Infrastructure Office, PSU Lingayen – West Campus, Alvear St., Lingayen, Pangasinan. This will be followed by the opening of sealed of quotation on 10:15 A.M. of the same day at the Right/Left Wing Don Telesforo Boquiren Convention Hall. You can submit your sealed quotation in person, or through a duly authorized representative.

The Pangasinan State University reserves the right to accept or reject any quotation, to annul the bidding process, and to reject all quotations at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
