The deadline for the submission of quotation shall be on or before 10:00 AM of February 5, 2024, at the BAC Secretariat - Infrastructure Office, PSU Lingayen – West Campus, Alvear St., Lingayen, Pangasinan. This will be followed by the opening of sealed of quotation on 10:15 A.M. of the same day at the Right/Left Wing Don Telesforo Boquiren Convention Hall. You can submit your sealed quotation in person, or through a duly authorized representative.

The Pangasinan State University reserves the right to accept or reject any quotation, to annul the bidding process, and to reject all quotations at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
