REQUEST FOR QUOTATION

The Pangasinan State University, intends to apply the sum of Nine Hundred Eighty Seven Thousand Nine Hundred Seventy Four Pesos (P 987,974.00), being the Approved Budget for the Contract (ABC) to payments under the contract for the "Purchase, Delivery and Installation of Electrical Materials for the Connection of Automatic Transfer Switch"

Bids received in excess of the ABC shall be automatically rejected at the opening of the quotation.

Financial bid to be tendered is by the entire lot and not by line item; hence, tendered financial proposal is understood to be good for all the items desired to be procured as presented in the Technical Specifications (Annex B).

The opening of quotation will be conducted as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Interested service providers may submit their sealed quotation at the Pangasinan State University, Lingayen, Pangasinan at the address given below during office hours at 8:00A.M.-5:00 P.M.

The deadline for the submission of quotation shall be on or before 10:00 AM of February 27, 2024, at the BAC Secretariat - Infrastructure Office, PSU Lingayen – West Campus, Alvear St., Lingayen, Pangasinan. This will be followed by the opening of sealed of quotation on 10:15 A.M. of the same day at the Right/Left Wing Dr. Telesforo Boquiren Convention Hall. You can submit your sealed quotation in person, or through a duly authorized representative.

The Pangasinan State University reserves the right to accept or reject any quotation, to annul the bidding process, and to reject all quotations at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
