## Description

PANGASINAN STATE UNIVERSITY

Invitation to Bid for Construction of Powerhouse at PSU San Carlos (Re-bid) Project Identification Number: 2024-INFRAPB-015-SC-RB

1. The Pangasinan State University through the Agency / Internal Budget / Income (164) – 2024 intends to apply the sum of Five Million Pesos (Php 5,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Powerhouse at PSU San Carlos (Re-bid) with Project Identification Number: 2024-INFRAPB-015-SC-RB. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Pangasinan State University now invites bids for the above Procurement Project. Completion of the Works is required One Hundred Eighty (180) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from Pangasinan State University, BAC Office for Infrastructure Projects, PSU West Campus, Alvear Street, Poblacion, Lingayen, Pangasinan and inspect the Bidding Documents at the address given below from 8:00 A.M. – 5:00 P.M.

A complete set of Bidding Documents may be acquired by interested bidders on October 26 – Nov. 18, 2024 from given address and website/s below BAC for Infrastructure Office, PSU West Campus, Alvear Street, Poblacion, Lingayen, Pangasinan and psu.edu.ph: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00).The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The Pangasinan State University will hold a Pre-Bid Conference on November 06, 2024 at the Dr. Telesforo Boquiren Convention Hall or the Library Building, PSU Main Campus, Alvear St., Poblacion, Lingayen, Pangasinan which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manner of manual submission at the office address as indicated below, on or before November 18, 2024 at 10:00 A.M. BAC for Infrastructure Office, PSU West Campus, Alvear St., Poblacion, Lingayen, Pangasinan. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on 10:30 A.M. at the Dr. Telesforo Boquiren Convention Hall or the Audio Visual Room, PSU Main Campus. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Pangasinan State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
