Description

Invitation to Bid for Fabrication and Installation of Automatic Fire Sprinkler System (AFSS) and Fire Detection & Alarm System (FDAS) for the 4-Storey Engineering and Research Bldg

- 1) The Pangasinan State University, through the Agency/Internal Fund intends to apply the sum of Ten Million Pesos (Php 10,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Fabrication and Installation of Automatic Fire Sprinkler System (AFSS) and Fire Detection & Alarm System (FDAS) for the 4-Storey Engineering and Research Bldg with Project Number 2025-INFRAPB-014-URD. - 2) The Pangasinan State University now invites bids for Fabrication and Installation of Automatic Fire Sprinkler System (AFSS) and Fire Detection & Alarm System (FDAS) for the 4-Storey Engineering and Research Bldg. Completion of the Works is required within One Hundred Fifty (150) calendar days from the date of issuance of NTP. Bidders should have completed, within Ten (10) Years from the date of submission and receipt of bids, a contract similar to the Project. latest Guidelines issued by the GPPB, in the amount of Ten Thousand (10,000) Pesos

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below BAC Office, PSU Lingayen West Campus, Alvear Street East, Lingayen, Pangasinan on or before 1:00 Pm, October 08, 2025. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9) Bid opening shall be on October 08, 2025 at Dr. Telesforo Boquiren Convention Hall, PSU Main Campus, 1:30 P.M.. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
