Description

Invitation to Bid for Construction of Grand Legacy Building Phase V, Lingayen Campus

- 1) The Pangasinan State University, through the Agency/Internal Fund intends to apply the sum of Eighty Million Pesos (Php 80,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Grand Legacy Building Phase V, Lingayen Campus with Project Number 2026-INFAPB-001-LING. Bids received in excess of the ABC shall be automatically rejected at bid opening.
 - 2) The Pangasinan State University now invites bids for Construction of Grand Legacy Building Phase V, Lingayen Campus. Completion of the Works is required within Three Hundred Sixty (360) calendar days from the date of issuance of NTP. Bidders should have completed, within Ten (10) Years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
 - 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR, otherwise known as the "New Government Procurement Act (NGPA)". Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
 - 4) Interested bidders may obtain further information from Pangasinan State University and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.
 - 5) A complete set of Bidding Documents may be acquired by interested bidders on January 21 – February 10, 2026 from the address below BAC Office, Pangasinan State University Lingayen West Campus, Alvear Street East, Poblacion, Lingayen, Pangasinan and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifty Thousand (50,000) Pesos
- It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The Pangasinan State University will hold a Pre-Bid Conference on January 29, 2026, 1:00 P.M. at Dr. Telesforo Boquiren Convention Hall, PSU Main Campus, Lingayen, Pangasinan which shall be open to prospective bidders.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below BAC Office, PSU Lingayen West Campus, Alvear Street East, Lingayen, Pangasinan on or before 1:00 Pm, October 08, 2025. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9) Bid opening shall be on February 10, 2026 at Dr. Telesforo Boquiren Convention Hall, PSU Main Campus, 1:30 P.M.. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 11) The Pangasinan State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
